ACKNOWLEDGEMENT & LIABILITY WAIVER

CleanConscience is a Charitable Incorporated Organisation (CIO), a charity in England and Wales with registration number 1160870 (hereinafter referred to as “**CleanConscience**”).

CleanConscience is committed to reducing the waste created by discarded hotel soap and bottled toiletry products and to preventing the millions of deaths caused by hygiene related illnesses around the world.

My participation in the **CleanConscience** activities is purely voluntary and I choose to participate.

Therefore, in exchange for being allowed to participate in the **CleanConscience** recycling activities, I assume and accept full responsibility for myself, for any risks, and for all injury, property loss or expenses suffered by myself or by any third party arising out of my own negligence or (to the extent allowed by applicable law) the negligence of **CleanConscience** or others.

RELEASE & INDEMNITY

I hereby agree, on behalf of myself and my children, heirs, executors, administrators and representatives, to the fullest extent allowed by applicable law, to release, indemnify and defend **CleanConscience** and **CleanConscience** Personnel with respect to all claims, liabilities, losses, suits or expenses (including costs and reasonable solicitors’ fees) made or brought by anyone, including myself, any co-Participant, volunteer, third party, or any members of my family arising out of any injury, damage, death, or other loss in any way connected with my participation in **CleanConscience** activities or use of **CleanConscience** equipment or facilities.

This agreement includes any losses claimed to be caused, in whole or in part, by the negligence of **CleanConscience** or **CleanConscience** Personnel. I agree to waive all claims against **CleanConscience** or **CleanConscience** Personnel, whether legal or equitable, and I agree that neither I, nor anyone acting on my behalf, will make a claim or file a lawsuit of any kind against **CleanConscience** or **CleanConscience** Personnel as a result of any injury, damage, death or other loss.

I agree that this and all other aspects of my relationship with **CleanConscience** are governed by English law. Further, any mediation, suit, or other proceeding arising out of or relating to my participation in **CleanConscience** Activities, must be filed exclusively in England, and English law shall apply. I agree to settle any dispute that cannot be settled by discussion through mediation before a mutually acceptable English mediator. I also agree that if I, or someone on my behalf, asserts(s) a claim or file(s) a suit against **CleanConscience** or **CleanConscience** Personnel, I will pay all costs and attorney’s fees incurred by **CleanConscience** in defending that claim or suit, if the claim or suit is withdrawn or dismissed, or to the extent a court determine that **CleanConscience** and/or **CleanConscience** Personnel is not responsible for the injury or loss.

While I agree that **CleanConscience** has no responsibility to provide medical care to me and makes no offer to do so, I authorise **CleanConscience** Personnel, should they deem it necessary, to obtain or provide such medical care for me as they deem appropriate, and/or to transport me to a medical facility should they deem it appropriate. I further authorise **CleanConscience** Personnel or any medical personnel to render such treatment they deem necessary for my health. I further agree to pay all costs associated with such care or evacuation whether or not authorised by me.

Without limiting any of the foregoing, I expressly waive any claims that I or anyone on my behalf may make against **CleanConscience** or **CleanConscience** Personnel with regard to medical care and the provision or failure to provide such care.
